IN 2008 SRC PROVIDED 159 RISK ASSESSMENT/PAINT INSPECTIONS, RELOCATION FOR 32 FAMILIES WHILE THE WORK WAS BEING DONE, AND HAZARD CONTROL SERVICES TO FAMILIES IN HENNEPIN COUNTY BY REPLACING 1,895 LEAD PAINTED WINDOWS, REMOVING LEAD PAINT FROM ANOTHER 160 CONTAMINATED WINDOWS, PROVIDING CASE MANAGEMENT SERVICES FOR 98 FAMILIES, AND SETTING UP AND CLEANING UP FOR 152 HOUSEHOLDS. IN OUR EFFORTS TO PREVENT LEAD POISONING WE SCREENED 1,422 CHILDREN UNDER AGE 6 AT 48 SCREENING EVENTS THROUGHOUT THE STATE OF MINNESOTA. ADDITIONALLY WE MADE 218 EDUCATIONAL VISITS TO HOMES IN HENNEPIN COUNTY TO FURTHER OUR MISSION TO HELP FAMILIES TO CREATE HEALTHIER HOMES. SRC ALSO PROVIDED LEAD SAFE WORK PRACTICES TO 232 INDIVIDUALS IN 20 TRAINING SESSIONS, TEACHING CONTRACTORS AND HOME OWNERS HOW TO WORK LEAD SAFE IN THEIR HOMES.
